<u>Adopt/Ordinance No. 2020-01 (RD) Transfer of Appropriation – Accounting Services</u> Trustee Gavin moved to take the matter from the table to address the issue. Seconded by Trustee Slattery. A roll call vote was taken. Ayes (5), Nays (0)²

Supervisor Vera called for discussion on the matter. No comments were made and no further action was taken.

Reports:

Supervisor Vera, reported the following reports were received, Animal Control, Senior, Cemetery and Highway Department. Clerk May commented these were emailed out to everyone. He also reported he continues with day to day responsibilities at the Township and Animal Control and he has been working at the cemeteries with spring cleanup and contracted services.

Clerk May, reported she completed the minutes from the March 24, 2020 telephone conference meeting and made arrangements for the telephone conference meeting this evening. Contracts were issued to K & D Landscape and Paul Cabay both for services at Oakwood Cemetery. The Annual Town Meeting was postponed due to the COVID 19 and will be rescheduled at a later date after the restrictions for in person meetings has been lifted. A cancellation notice was posted at the Township Building, the Office of the Clerk, and the Town Hall meeting room. She also noted, the financial reports were received for the meeting and will be made available prior to the future meeting date. She reported working remotely daily and physically coming into the office at least 2 times per week. When not physically at the office, she is routinely checking her emails and voice mails.

Assessor Brenczewski, reported he is physically coming into the office, taking care of day to day matters.

Attorney Harvey, reported he continues to work with the officials and staff to address routine matters.

Accountant Witt, reported she is working remotely daily and is physically in the office when necessary. She completed the February and March bank reconciliations and they are in her office for review or review at a future meeting date. She will complete the March financials to include yearend once all accruals are completed. The preliminary

rate has been received from IMRF, currently we are at 4.13% and it is doing down to 3.45%. The Quarterly payroll taxes have been completed and filed. The FY '20 budget was updated per the transfers from the March 24, 2020 meeting. She completed the Supervisors Statement of Financial Affairs, and the Road District Annual Report, from the Treasurer of the District, for the Annual Town Meeting.
