The Regular Meeting via Telephone Conference held at 175 West Jefferson Street, Joliet Township government offices, on Tuesday, June 9, 2020, at 5:00 p.m. Supervisor Daniel Vera, Attorney Jim Harvey, and Temporary Deputy Clerk Julie Kinsella were present at the Town Hall meeting room. Attorney Jim Harvey executed the Warrant of Appointment and administered the oath of office to Julie Kinsella for Temporary Deputy Town Clerk. Julie Kinsella recited the oath to carry out the duties of Temporary Deputy Town Clerk.

Public Comment:

Supervisor Vera acknowledged that no emails were received to be read under public comment. Two persons, Anna Donavan and Kirk Allen had comments for the board:

<u>Anna Donavan</u> via phone commented that she did not appreciate what she considered uncalled for comments by former Clerk May and hopes Clerk May's retirement brings her happiness. Donavan did not like the Township handling of Covid-19 and she felt meetings put public health at risk. She did appreciate the phone option for meeting participation once that was in place. Donavan would like the phone option to continue. She also spoke to her desire that the Township meetings are open to all and that the Township will not keep the residents in the dark. Donavan stated that she did not feel posting of meeting notice on Friday at 4PM prior to meeting on the following Tuesday gave public enough notice. She would like Township meeting times to not conflict with other governmental agencies, notably that of City of Joliet. Donavan also did not want the Township to "overstep and limit public freedom".

PUBLIC COMMENT- <u>Kirk Allen</u> via phone stated that he disagreed with several Township meeting policies and recommended new legal counsel for the Township Board if current counsel is the one who gave advice on this area. Regarding directing public to specific person/trustee or department, he did not agree. Regarding the policy that profanity shall not be used, Allen stated that he would be (*expletive*) if the Township would limit his choice of words. Regarding not allowing an individual appearing under the influence of alcohol/drugs to address the board. He did not feel it was within the purview of the Township to judge and that he felt the Township should not limit freedom of the public to speak.

The Public Hearing was called to order at 5:18 p.m. by Temporary Deputy Clerk Kinsella who verified the legal notice was published in the Joliet Herald-News on Friday May 8, 2020 and read the legal notice into the record. The Public Hearing Notice on said Budget & Appropriation Ordinance No.363-2020 was read by the Temporary Deputy Town Clerk Kinsella.

Public Comment:

Temporary Deputy Town Clerk Kinsella opened the Public Hearing for Ordinance No. 363-2020 for Public Comment and called three times asking if any members of the public were on the call and wished to speak and there was no response. Hearing no response, Kinsella stated that this ordinance will not be approved at the Public Hearing but at the Regular Meeting, previously recessed and called for a motion to close the Public Hearing and return to recessed Regular Meeting.

Highway Commissioner Turnbull Report: Turnbull requested that the Highway Commissioner's Report be included in these minutes of the Township Board meetings. Turnbull stated that the monthly highway commission report were sent by Clerk May to the Will County Engineers. Issuance of permit on crosscuts were not issued by and was not authorized by him but were initiated and signed by Clerk May and not him. He wanted to know where the money is for those permit bonds. Turnbull further stated that he has contacted the Highway Department's legal counsel and asked him to contact the State's Attorney with this issue. Turnbull also stated that former Clerk May had not provided documents to him regarding prior spending and budget items needed for submitting documents for his budget before the end of month. Turnbull stated that he plans to submit his budget at the next Township Board meeting of June 23, 2020. Turnbull continued, 364-2020 stating that it appears to him to give Township Board additional spending powers, contrary to his interpretation of state statute and he believes is unlawful. Also regarding 2020-04 Surplus Equipment, he questions why items are not specified. He noted 3 computers from Animal Control he thought needed a certificate of destruction. He also questions whether records exist that certify that computers destroyed from Animal Control have been certified as "destructed" prior to being sold, refurbished or recycled. He also cited 2020-05 Public Participation which he thinks has been designed to prevent right of public to speak; and said the Township Board should be prepared for some citizens to "let you have it."
